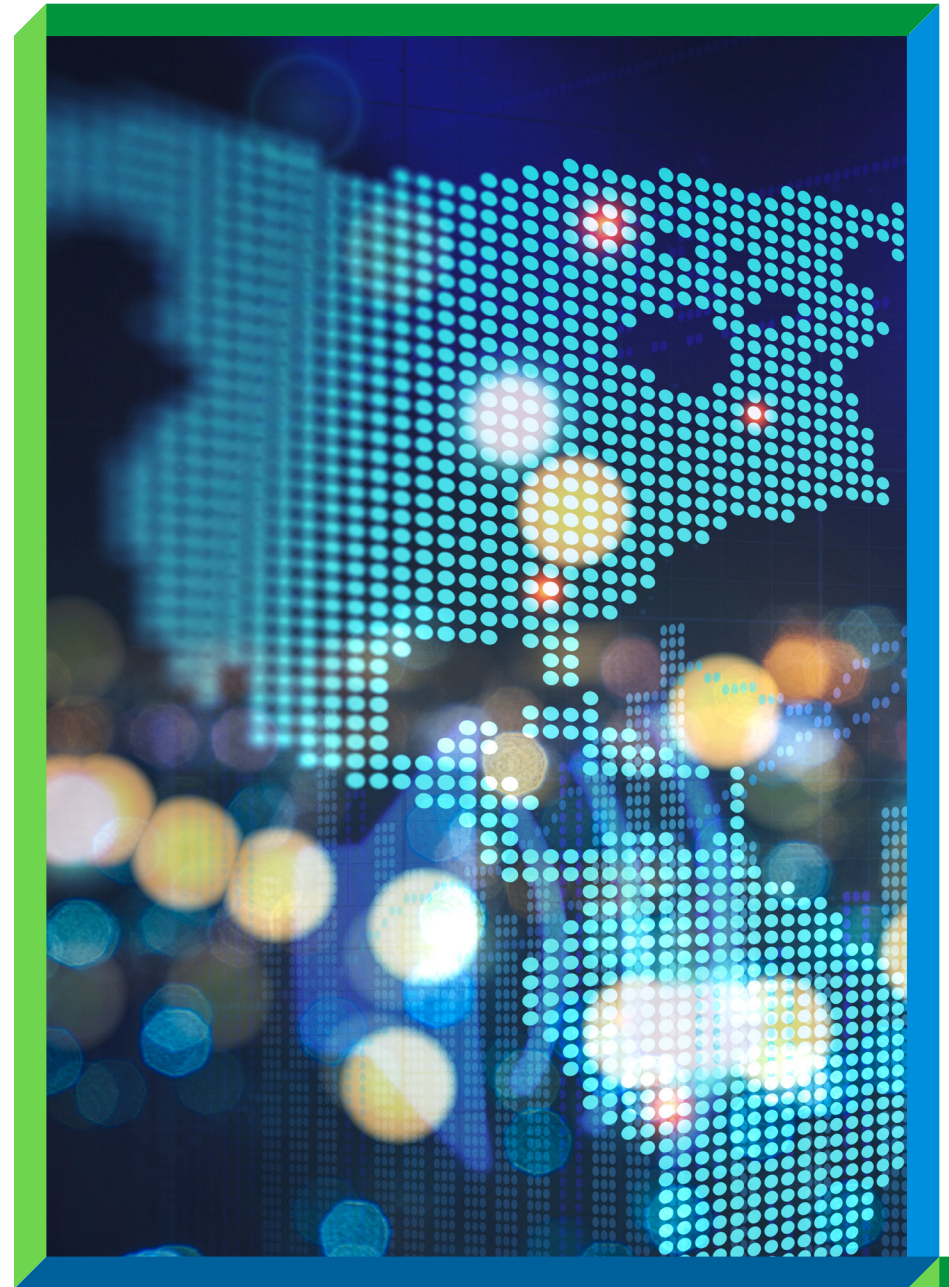

## Additional Information

- + There were no state sales tax changes in 2020.
- + Puerto Rico currently has the highest state sales tax rate at 10.500%. Indiana, Mississippi, Rhode Island and Tennessee have the second highest state sales tax rates at 7.000%.
- + Kodiak, Alaska, Wrangell, Alaska and Winter Park, Colorado have the highest city sales tax rate at 7.000%. Hoonah, Alaska, Klawock, Alaska and Selawik, Alaska have the second highest rate of 6.500%.
- + Sterlington with the Sterlington Economic Development District No. 1, Ouachita Parish, LA has the highest combined sales tax rate of 12.950%.
- + Since 2011, there have been 2202 new sales and use taxes, an average 220 per year.
- + Since 2011, there have been 3555 sales and use tax changes, an average of 355 per year.
- + The combined number of new and changed sales and use tax rates since 2011 is 5757, an average of 575 per year.
